

**Note:** Candidates without Interview call letter will not be allowed to attend the Interview.

5. **Certificate verification:** Candidates are advised to bring all the original certificates/ documents viz. educational qualifications, community certificate (if applicable), NOC from current employer (if applicable), experience certificate(s), photo id proof like Aadhar Card, Voter I-Card or any other Photo ID Card issued by any Government Agency for verification/ counter verification with interview call letter.
6. **Candidature for Interview:** If it is found at any point of time, even after selection, that the candidate does not fulfil any of the conditions of eligibility for the post advertised vide CLRI Advt. No.2/2021, his/her candidature will be summarily cancelled without any notice and no appeal against such cancellation will be entertained. Candidates are, therefore, advised to check carefully and satisfy themselves that they fulfil all conditions of eligibility for the post they have applied for.
