Sub: Intimation regarding conduct of Competitive Written Examination, non-shortlisting of candidates, **confirmation of willingness** to appear for the Competitive Written Examination by provisionally allowed candidates for recruitment to the post of Junior Stenographer (CLRI Advt. No.02/2026) – Reg.

With reference to the recruitment to the post of Junior Stenographer, advertised against Post Code: JST2601 of CLRI Advt. No.02/2026 dated 23.01.2026, the following are hereby notified for all concerned:

**1. SEQUENCE OF EXAMINATION:**

The Selection Committee, constituted by the Competent Authority, CLRI has decided to conduct the recruitment process in the following sequence.

- I. Competitive Written Examination; and
- II. Proficiency Test in Stenography

*(Only those candidates who qualify in the Competitive Written Examination will be called for Proficiency Test in Stenography).*

**2. PRELIMINARY SCREENING RESULTS:**

A total of **8,383** applications were received up to the closing date, i.e., 02.03.2026.

In view of the voluminous applications, the Screening Committee, after preliminary screening of applications, resolved that applications found to be duplicate and/or not accompanied by the prescribed application fee are not eligible for participating in the examination.

Accordingly, 118 candidates, whose details are provided in **ANNEXURE-I** are **NOT** recommended to participate in the Competitive Written Examination.

All remaining candidates are PROVISIONALLY permitted to appear for the Competitive Written Examination, subject to detailed verification in the Final Screening Stage.

*Note: If, in any case, it is found that a candidate does not fulfill the prescribed eligibility criteria or has submitted incomplete, incorrect, invalid or irrelevant documents (including mismatched information and improper uploads), their candidature shall be rejected without further notice. The candidates are, therefore, advised to check carefully and satisfy themselves that they fulfill all the conditions of eligibility for the post of Junior Stenographer. Mere appearing for Competitive Written Examination does not confer any right on them for substantive appointment in CLRI.*

**3. SCHEDULE OF COMPETITIVE WRITTEN EXAMINATION:**

The Competitive Written Examination for recruitment to the post of Junior Stenographer (Post Code: JST2601) will be conducted as per the below schedule:

*Note: The exact time and venue of the Competitive Written Examination will be notified in the individual Admit Card of the Candidates.*

4. **CONFIRMATION OF WILLINGNESS TO APPEAR IN THE COMPETITIVE WRITTEN EXAMINATION:**

In order to facilitate effective planning and conduct of the Competitive Written Examination, including allocation of examination centres and generation of Admit Cards, candidates who intend to appear in the examination are required to **confirm their willingness** through the online recruitment portal (through which the application was submitted) during the period **from 12.06.2026 to 19.06.2026 (both days inclusive)**.

Only those candidates who submit their willingness through the recruitment portal within the stipulated period shall be considered for generation of Admit Cards for the Competitive Written Examination.

*Note: Submission of willingness shall not confer any right upon a candidate for admission to the examination. Admission to the Competitive Written Examination shall remain subject to fulfilment of the eligibility conditions prescribed in Advertisement No. 02/2026.*

5. **ADMIT CARD:**

Instructions regarding downloading of Admit Card will be notified in CLRI Website in due course. Candidates are, therefore, advised to regularly visit CLRI Website for updates and further instructions relating to the recruitment process.

6. **TRAVEL & STAY ARRANGEMENTS:**

Candidates have to take care of their travel & stay arrangements by themselves. CLRI will not bear any expenditure in this regard.

7. In case of any discrepancy, technical issue, administrative exigency or unforeseen circumstances, CSIR-CLRI reserves the right to modify the schedule or issue appropriate instructions, which shall be notified through CLRI Website.
