4. The point (ii) of essential qualification i.e. Knowledge of motor mechanism (The candidate should be able to remove minor defects in vehicle) will be verified during the Stage – I (Skill Test).

Applicants who are shortlisted with 'Subject to Production' remarks shall submit the requisite documents to [recruit.clri@csir.res.in](mailto:recruit.clri@csir.res.in) on or before 29.08.2025 (Friday). In case of non-submission of required documents before the stipulated date, their candidature will not be considered further and will be summarily rejected.

6. Any representation, along with the requisite documents by the applicant(s) (other than those mentioned in Para 5), may be sent through email to recruit.clri@csir.res.in on or before 29.08.2025(Friday). Representations received beyond the stipulated date, will not be entertained.

7. Please note that no representation from applicant(s) seeking an extension of the deadline for submission of any documents will be considered.

8. It is stated that, upon receipt of the representation and requisite documents, and after their scrutiny, a modified list of Shortlisted and Non-Shortlisted Applicants will be published on the CLRI website.

9. The date, time and venue of Competitive Written Examination will be intimated in due course, well in advance of scheduled date of examination.

10. The **shortlisting of applicants** to the aforementioned post is **provisional**. If it is found later at any point of time, even after appointment, that the applicant does not fulfil any of the conditions of eligibility for the post notified vide CLRI Advt. No. 03/2025, his/her candidature will be summarily cancelled / terminated without any notice and appeal against such cancellation / termination will not be entertained. Applicants are, therefore, advised to check carefully and satisfy themselves that they fulfil all conditions of eligibility for the post they have applied for.
